CORONAVIRUS AND CONTRACTUAL FORCE MAJEURE

In all of art 1733 CCC cases the act of God or force majeure event does not have the usual consequence - that of art 1730 CCC- of waiving the debtor's liability Acts of God or force majeure events can cause the frustration of the contract or merely a temporary hardship, but the effects of both situations may coincide
